



Notification

In supersession of this office notification No.UHF/Bud/2-57/Vol-IV/2011-12/-2233-83 dated 25th May, 2012, the Hon'ble Vice-Chancellor, Dr. Y.S. Parmar, University of Horticulture & Forestry, Nauni-Solan is pleased to revise/enhance the rates for hiring the ordinary taxi cabs up to 6 seats for Non-Tribal Areas from the existing rates of ₹ 8.74 per kilometer to ₹13.14 per kilometer and for Tribal Areas from ₹ 9.61 per kilometer to ₹ 14.01 per kilometer, with night halt charges (from 10.00 P.M. to 6.00 AM (for outstation) from ₹ 110 per night to ₹ 200/- per night on the analogy of Notification No. Tpt-F(5)3/2003-1 dated 27th November, 2018 issued by the Principal Secretary(Transport) to the Govt. of Himachal Pradesh, subject to the following terms and conditions:-

1. The taxi(es) shall be hired in case of non availability of university vehicle with the concerned College/Department.
2. The hiring of taxi(es) shall be resorted to a group of scientists/officials/functionaries or for carrying material etc. or in the event of the exigency of work so required, in which case prior approval of the Hon'ble Vice-Chancellor shall be obtained.
3. The taxi(es) shall only be hired for bonafide work of externally aided projects only.
4. It shall be ensured before hand that funds under the appropriate/approved SOE are sufficient to meet the charges.
5. The taxi(es) shall not be hired for undertaking journey outside the state except with the express prior approval of the Hon'ble Vice-Chancellor.
6. The touring has to be productive one and tour programme duly approved by the competent authority.
7. The liability of payment of taxes for plying the taxi within/outside the state shall be that of the owner of the vehicle.

These instructions may kindly be adhered to in letter and spirit. The revised rates will be effective from the date of issue of the Government's notification.


