



Applications are invited on prescribed form for admission to **one year** (2-semesters) practical oriented **Diploma Programme in Fruit & Vegetable Processing and Bakery Products** of this University for the Academic Session 2018-19.

Number of Seats: 35 (Open for all)

Minimum Qualification: 10+2 or equivalent examination from a recognized University/ Board with a minimum of 40% aggregate marks (35% marks in case of SC/ ST).

Eligibility: The basis of admission shall be merit as determined by the 10+2 examination. In case two or more candidates obtain the same percentage of marks, the elder in age shall be considered for admission.


Reservation of Seats: 22.5% of the total seats shall be reserved for Schedule caste (15%) and scheduled tribe (7.5%). The benefit of reservation shall be applicable to the bonafide residents of Himachal Pradesh. In case, the candidates in either of the two categories are not available, the seat(s) will be interchangeable.

Last Date for submission of application form in office of the Registrar is **17th January, 2019**. The **counselling** will be held on **19th January, 2019 at 11.00 AM** in the office of **the Dean, College of Horticulture, Nauni-Solan**.
