OFFICE ORDER

In view of the instruction dated 14th March, 2020 issued by the Additional Chief Secretary (Health) to the Government of Himachal Pradesh regarding closure of educational institutions as a measure to prevent the pandemic conditions arising out of Novel Coronavirus (COVID-19), the **University Authority has decided that the classes at main campus (College of Horticulture and College of Forestry) and its constituent colleges** i.e. CoH&F, Neri (Hamirpur) and College of Horticulture and CEHR&E, Thunag (Mandi) **will remain suspended with immediate effect** till 31st March, 2020. **The mid-term examinations or any other internal examinations of different degree programmes have also been postponed till further orders.** The students can keep residing in the hostels with all due precautions. In case of foreign students, if they visit other state or home country during this period they must inform their travel plan to the Students' Welfare Officer/concerned Wardens.

All the functions at main campus and outstations such as seminars, conferences, workshop or any such group activity shall also stand postponed/cancelled upto 31st March, 2020. **All the students are advised to remain in touch with the University website for any further instructions.** However, the teaching and non-teaching staff shall attend their respective offices/duties as usual.
