Qualification:

1. For the posts from Sr. No.1 to 5 (Assistant Professor/equivalent & Subject Matter Specialists):

- (i) Ph.D. Degree in the concerned subject relaxable to M.Sc. with consistently good academic record i.e. 55% marks at Master's level.
- (ii) A relaxation of 5% from 55% to 50% of marks at Master's level shall be provided to SC/ST categories.
- (iii) A relaxation of 5% will be provided from 55% of marks to the Ph.D. degree holders who have passed their master's degree prior to September, 1991.
- (iv) For the candidates having Master's degree, NET shall remain compulsory along with one publication in NAAS (National Academy of Agricultural Sciences, New Delhi) rated referred journal for recruitment to the post of Assistant Professor and equivalent in the disciplines in which NET is conducted. Essentiality of NET can be waived off for the candidates holding Ph.D. degree provided it has been done with course work as prescribed by the UGC Regulations, 2009, and the candidate has at-least two full length publications having a NAAS rating not less than 4, on the last date of submission of application. Those candidates with Ph.D. degree without course work will not qualify for NET exemption. Further, this will be implemented with perspective date i.e. w.e.f. 01st January, 2012.

For the candidates registered for Ph.D. prior to 11.07.2009, NET essentiality for recruitment to the post of Assistant Professor and equivalent in the disciplines in which NET is conducted, shall be exempted subject to the condition that:

- a) Ph.D. degree of the candidate awarded in regular mode only;
- b) Evaluation of the Ph.D. thesis by at least two external examiners;
- c) Open Ph.D. viva-voce of the candidate had been conducted;
- d) Candidate has published two research papers from his/her Ph.D. work out of which at least one must be in referred Journal;
- e) Candidate has made at least two presentations in conference/seminars, based on his/her Ph.D. work.

(a) to (e) as above are to be certified by the Vice-Chancellor/Pro Vice-Chancellor/Dean (Academic Affairs)/Dean (University Instructions).

- (v) 'B' in the 7-point scale with letter grades, O, A, B, C, D, E & F shall be regarded as equivalent to 55%, wherever the grading system is followed.

2. For the post at Sr. No.6 (Peon):

Essential: Should have passed Matriculation Examination or its equivalent from recognized Board of School Education/Institution.

Desirable: Knowledge of customs, manner and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

3. For the post at Sr. No.7 (Beldar):

Essential: Should be Primary Pass from a recognized School/Institution.

Desirable: Knowledge of customs, manner and dialects of Himachal Pradesh and suitability for appointment in the peculiar conditions prevailing in the Pradesh.

IMPORTANT INSTRUCTIONS/OTHER CONDITIONS:

1. The detail of application fee for the above mentioned posts is as follows:

Note: The application forms on cash payment will not be sold by the Recruitment Section.

2. Application fee once paid will not be refunded.
3. The applicant must be a Citizen of India.
4. Those Ph.D. candidates (applying for the posts at Sr. No.1,2,3,4 & 5), whose registration in their Ph.D. Programme is prior to 11.07.2009 and are not NET qualified, will have to submit the "Certificate of NET exemption", issued in their favour, from the competent authority of University/Institution, from where they had qualified their Ph.D., verifying therein points (a) to (e) prescribed at Sr.No.1(iv) under the heading "Qualification" above, with their application form, failing which their application is liable to be rejected straightway.
5. The posts at Sr. No.6 & 7 are for "bonafide Himachali's only.
6. Candidate should be minimum of 18 years and not more than 45 years of age. The upper age limit is relaxable by five years for candidates belonging to the Scheduled Caste/Scheduled Tribe/Other Backward Class/Persons with Disabilities, of Himachal Pradesh only, as per provisions in Rules/Instructions of the H.P. Government. The minimum and maximum age limit shall be reckoned on the concerned last date fixed for receipt of applications. It is

further clarified that the upper age limit fixed in the advertisement shall not be applicable in case of candidates already in service in Government/Semi-Government/Recognized Institutions.

7. These posts will be filled up purely on contract basis initially for a period of one year which may be extendable on year to year basis.
8. The candidate selected for appointment to the above posts on contract basis shall have to execute a contract with the University i.e. Dr. YSP UHF as per rules of the University.
9. The date of determining eligibility of all candidates in respect of essential qualification (s) and experience, if any, shall be the prescribed last date for receipt of applications i.e. 04.09.2018 for candidates from Non Tribal Areas and 19.09.2018 for candidates from tribal areas.
10. Evaluation of a candidate for the posts from Sr. No.1 to 5 will be done in accordance with the Scorecard framed and notified by the University, vide Notification No.UHF.Regr.Rectt.2-02/2013/-32693-728 dated 28.12.2013 which is available on the university website <http://www.yspuniversity.ac.in>. For the purpose of awarding marks as per criteria prescribed in the Scorecard except presentation and interview of a candidate, the last date of receipt of applications will be reckoned and no marks for the achievement(s) gained, during the intervening period i.e. from the last date of receipt of applications and the date of interview will be given.
11. In view of Department of Personnel's, Government of HP, Notification No.Per(AP.B)B(15)-5/2014 dated 17.04.2018, further adopted by the University, vide Notification No.UHF.Regr.Rectt.2-39/2017/-27703-27745 dated 26.12.2017, for the posts mentioned at Sr. No.5 & 6 above, the selection shall be made on the basis of percentage of marks obtained in qualifying examination to be calculated out of 85. For example, a candidate getting 50% marks in Matric will be given 42.5 marks followed by evaluation, based on the following parameters. Besides, there will be physical test for the post of Beldar which will be of qualifying nature, only:

Note: For item No.(ii) to (ix), the authority competent to issue certificate is as per letter No.Per(AP-B)B(15)5/2014-loose-I dated 18.07.2017 issued by ACS (Personnel) to the Government of HP, further adopted by the University, vide Notification No.UHF.Regr.Rectt.2-39/2017/-27703-27745 dated 26.12.2017.

12. The posts at Sr. No.5, 6 & 7 will be filled up under newly established Krishi Vigyan Kendra, Tabo, Lahaul & Spiti. The candidates appointed against these posts will have to serve minimum 5 years there with KVK and thereafter they are liable to be transferred within the Krishi Vigyan Kendra's of the University.
13. A candidate applying for more than one post should send separate application form for each post alongwith prescribed application fee.
14. Applicants already in service should send their application forms through proper channel with advance copy to this University.
15. Number of post(s) is/are tentative and may increase or decrease from time to time for different categories of post.
16. The reservation indicated above has been given as per rules/instructions of the State Government and the same will be provided to candidates of Himachal Pradesh only. The reserved category candidates belonging to other states will be treated as **GENERAL CATEGORY CANDIDATES** and **the benefit of reservation and fee concession will not be admissible to such candidates.**
17. Canvassing direct or indirect will be a disqualification.
18. Any further information about qualifications or job requirements can be had from the Recruitment Section, office of the Registrar.
19. Incomplete applications or those received after the last date will not be entertained and rejected straightway.
