NOTIFICATION

In continuation of this office notification No. UHF/Regr(Acad)/4-22(106th)/2020/4186-4210 dated 11.06.2020, the following amendments are hereby made to ibid notification for Students Research and its Evaluation for the Academic Session 2020-21 as here under:-

1. Para C of the ibid notification stands modified as under:

- *In case of M Sc students, after receiving thesis evaluation report from the External Examiner, the thesis viva-voce examination shall be conducted by the Internal Examiner (not below the rank of Associate Professor) appointed by the concerned Dean from the related field within the college. The viva-voce examination can be done online in case the student cannot be physically present only with the written consent of the HoD and concerned Deans.*

2. Para D of the ibid notification stands modified as under:

- *In case of Ph D students, thesis evaluation and conduct of thesis viva-voce examination, if urgent and where external examiner or the student are unable to visit University due to COVID-19, the same will be conducted through video conferencing apps”*

3. Additional para ‘f’ is hereby added to the ibid notification as under:

‘f’ Thesis Submission by M Sc/Ph D students

- i) During the time of rough submission of thesis by the students in the office of the concerned Deans, physical appearance of the student is not mandatory. In this regard, the students should submit a written request to the Dean, after obtaining consent of his /her major advisor/HOD.
- ii) A hard copy of rough thesis duly signed, will be sent by the student through Registered/speed post or courier to the Major Advisor .
- iii) After successful completion of the thesis & viva-voce examination, the final thesis submission in the form of hard copy will be done by the student through Registered/speed post or courier.

The other contents of the ibid notification shall remain same.
