3. Lighting of candles and kerosene oil/lamps etc will not be allowed.
4. The damage to the property during the use of Auditorium will be the sole responsibility of the individuals/organizers concerned for which they will be liable to make good for the loss.
5. Additional Rs. 5,000/- for diesel for generator set per day to be borne by the organizer.
