On the recommendations of the SE-cum-Estate Officer, the Hon'ble Vice-Chancellor, Dr. Y.S. Parmar, University of Horticulture & Forestry, Nauni-Solan has been pleased to approve the revised rates/charges to be chargeable from the vendors/salesmen/owners of private commercial vehicles, visitors entering the University premises with immediate effect. The detail of charges are given as under:-

Sr. No.	Particulars	Revised Rate
1.	Charges for selling products in car/van three wheelers/scooters	Rs. 500/- per day per head
2.	Charges for selling products in light vehicles(Swaraj Mazda/Tractors	Rs.700/- per day per head
3.	Charges for selling products in heavy vehicles.	Rs. 1000/- per day per head
4.	Charges for selling products without vehicle.	Rs. 200/- per day per head
5.	(i) Charges for putting on canopy in open space. (ii) Charges of canopy plus vehicle	Rs. 1000/- per day per canopy displaying vehicle and testing Rs. 4000/- per day.
6.	Swaraj Mazda/Canter etc. entering the University premises for commercial purpose.	Rs. 150/- per trip per head or Rs. 1500/- per month.
7.	Heavy vehicles viz., truck etc entering the University premises for commercial purpose.	Rs. 300/- per trip per vehicle or Rs. 2000/- per month.
8.	Tourist buses excluding student tour	Rs. 300 - per day per bus.
9.	Private buses entering the University premises.	Rs. 450/- per month for single trip per day and Rs. 750/- per month for more than one trip per day.
