



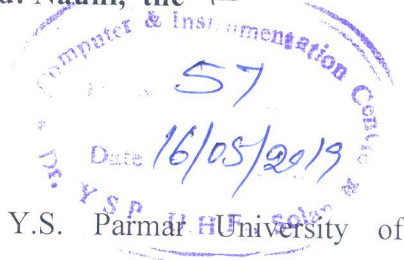



NOTIFICATION

In exercise of the powers conferred by proviso to article 309 of the Constitution of India, the Governor, Himachal Pradesh is pleased to make the following rules, further to amend the Himachal Pradesh Civil Services Contributory Pension Rules, 2006, notified vide this department's notification of even No, dated 17.08.2006, namely:-

1. Short title and commencement.

I. (1) These rules may be called the Himachal Pradesh Civil Services Contributory Pension (First Amendment) Rules, 2019.

(2) These rules shall come into force from 1st day of April, 2019.

2. Amendment of rule 4.

In rule 4 of the Himachal Pradesh Civil Services Contributory Pension Rules, 2006,-

(a) for the existing provision against sub-rule (2), the following shall be substituted, namely:-

"The monthly contribution ~~at~~ 14% of the Basic Pay, DA & NPA (wherever applicable) shall be made by the State Government every month for each employee, who contributes to the Scheme"; and

(b) for the existing provision against sub rule (21), the following shall be substituted, namely:-

"The reasons for non-recovery from a particular employee in any month shall be furnished by the Drawing and Disbursing Officers concerned, in the recovery schedule, without fail. Whenever an
