OFFICE MEMORANDUM

Subject: Grant of Dearness Allowance to the employees of the State Government w.e.f. 01.07.2019.

In continuation of this Department's OM of even number dated the 21st August, 2019, the Governor, Himachal Pradesh, is pleased to enhance Dearness Allowance @5% from the existing rate of 148% to 153% with effect from 01.07.2019 in respect of the employees of the State Government and @ 5% from existing 12% to 17% in respect of the officers of All India Services who are drawing pay in the revised pay scales.

2. This additional rate of Dearness Allowance of 5% (Five percent) shall be paid in cash with the salary of March, 2020 payable in April, 2020 and the arrears accrued from 01.07.2019 to 29.02.2020 shall be credited in the GPF Accounts of the employees in the month of March, 2020. The interest on this account shall accrue w.e.f. 1st April, 2020.

3. In the case of Government employees who have retired in between or who have closed GPF Accounts and employees who are governed under Contributory Pension Scheme, the arrears on account of release of additional installment of DA w.e.f. 01.07.2019 will be paid in cash in the month of March, 2020.

4. Other terms and conditions as contained in OM of even number dated 26th August, 2009 shall continue to be applicable.

5. These orders will be applicable to the regular employees covered by HP Civil Services (Revised Pay) Rules, 2009, HP Civil Services (Category/Post-wise Revised Pay) Rules, 2012 and Work charged employees drawing pay under Pre-revised Scale. These orders will also apply to HP Judicial Services Officers and State Government employees covered by UGC Pay Scales.

6. The payment on account of Dearness Allowance involving fraction of 50 paise and above may be rounded off to the next higher rupee and the fraction of less than 50 paise may be ignored.
