### NOTIFICATION

The open tenders were invited to outsource the unskilled labour services for the period 01.04.2017 to 31.03.2018. the rates quoted by **M/S Rainbow Enterprises, Hemant Lodge, Mashobra (2<sup>nd</sup>) Tehsil and District, Shimla (H.P)- 171 007** have been approved on the basis of single tender and negotiation for offering service/administrative charges i.e. 4 percent. The rates shall be applicable from **01.04.2017 to 31/03/2018**. The minimum wages are, however, subject to the revision by the State Government and adoption of the same in the University. The agreement is being signed between Dr. Y.S. Parmar University of Horticulture and Forestry, Nauni-Solan ( first party) and **M/S Rainbow Enterprises, Hemant Lodge, Mashobra (2<sup>nd</sup>) Tehsil and District, Shimla (H.P)- 171 007** (second party) which shall be uploaded on [www.yspuniversity.ac.in](http://www.yspuniversity.ac.in). The outsource services shall strictly be as per terms and conditions agreed upon by the second party. ( copy of terms and conditions shall also be available on the University website) The outstations of the university are also covered under this contract.

The Head of the Departments/Associate Director of Regional Stations/ Incharge of Research Stations and other functionaries engaging unskilled labour in the University shall be bound to outsource required manpower for the above mentioned period for smooth conduct of research work after getting one time approval and sanction of mandays and expenditure respectively of each scheme/project from the competent authority :

Therefore, it is enjoined upon all concerned that :

1. The scheme/project wise total requirement for the period 01.04.2017 to 31.03.2018 may be given to the agency after obtaining the sanction of the competent authority strictly as per the requirement of mandays supplied earlier.
2. It may be ensured that the unskilled services are outsourced to **M/S Rainbow Enterprises, Hemant Lodge, Mashobra (2<sup>nd</sup>) Tehsil and District, Shimla (H.P)- 171 007**. The agency will open its local office near the surrounding of the University. Henceforth, no other mode of engagement of workers shall be applicable and individual concerned shall be responsible for any violation of norms for outsource services.
3. It may also be ensured that the attendance of the workers supplied by the contractor maybe verified for number of mandays supplied and utilized for university project work and he has given a paid holiday after six continuous working days by the PI/FM/FA/HOD. Subsequently the attendance sheet may be sent to **M/S Rainbow Enterprises, Hemant Lodge, Mashobra (2<sup>nd</sup>) Tehsil and District, Shimla (H.P)- 171 007** on the last working day of the every month without fail so that payment reaches the workers on or before 7<sup>th</sup> of the every month.
