Short Title: This amendment may be called Dr. Yashwant Singh Parmar University of Horticulture and Forestry, Nauni (Solan) Statutes, 1987 (55th Amendment, 2017)

Amendment/addition to Statutes 5.7 (3) (c) & (d) of Chapter-V of Dr. Yashwant Singh Parmar University of Horticulture and Forestry Statutes, 1987

The following amendments shall be made under Statute 5.7 (3) (c) & (d) of Dr. Yashwant Singh Parmar University of Horticulture and Forestry Statutes, 1987:

Statute No.	Existing Provision	Amended/added Provisions
5.7 (3)	(c) The Screening Committee after scrutinizing the qualifications of the applicants, shall prepare the list of candidates to be called for interview and place the same before the Vice-Chancellor for his approval.	(c) For Class-I & II posts, the Screening Committee after scrutinizing the qualifications of the applicants, shall prepare the list of candidates to be called for written test/interview and place the same before the Vice-Chancellor for approval. However, in respect of Class-III & IV posts, the Screening Committee after scrutinizing the qualifications of the applicants, shall prepare the list of candidates to be called for written test or practical test or skill test or physical test, as the case may be, as prescribed in Notification No.Per(AP-B)B(15)-5/2014 dated 17.04.2017 issued by the Chief Secretary to the Government of Himachal Pradesh or amendments/instructions issued by the State Government on the subject from time to time, and place the same before the Vice-Chancellor for approval.
