OFFICE ORDER

In pursuance of the decision of the Board of Management taken, vide Item No.20 of its proceedings of 105th meeting held on 13.07.2018, on the basis of recommendations made by the Committee constituted, vide Office Order No.UHF.Regr.Rectt.2-39/2017/-14361-64 dated 17.08.2017 after reconsidering the absorption case of Shri Anil Gupta who was appointed as Technical T-II-3, purely on co-terminus basis in the running pay scale of Rs.4400-7000 (further revised to Rs.5910-20200+2800 GP), vide letter No.UHF.Regr.Rectt.2-04/2006/-6939-47 dated 01.07.2006 and later-on absorbed against the post of Field Assistant Gr-I, vide Office Order No.UHF.Regr.Rectt.2-39/2017/-16762-79 dated 07.09.2017, the Vice-Chancellor, Dr. Y.S. Parmar University of Horticulture & Forestry, Nauni (Solan) is pleased to absorb his services against the post of Technical Assistant in the pay scale of Rs.10300-34800+3600 GP, instead of Field Assistant Gr-I in the pay scale of Rs.5910+20200+2400 GP. However, he will continue to work under the project "AICRP on PHT" and his salary will continue to be charged against the post of Technical T-II-3 under the scheme HCR-135-05 till the funding in the concerned project is received.
