In view of the closure of University main campus and its constituent colleges for students upto 26th January, 2022, as per office order No. UHF/Regr/GA/6-36/2022/-36461-512 dated 09.01.2022, and in continuation of this office Important Notice No. UHF/Regr(Acad)/4-1/2021/35306-334 dated 01.01.2022, it is informed that **the candidates who were selected during 1st and 2nd counsellings** of Undergraduate programme, but failed to deposit online fee /registration card **are required to deposit online semester fee** directly in the concerned bank account (as per ibid notice dated 01.01.2022) by **11th January, 2022**. Further the candidates are **required to submit registration card and proof of deposition of full/balance fee physically in the respective colleges on or before 12th January, 2022** failing which admission shall stand cancelled.
