

Regarding Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 thereof.

Madam/Sir.

On the foregoing subject it is informed that the Govt. of India, Ministry of Women & Child Development has formulated a new version of SHe - Box which will serve as a central repository of data and complaints under "The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act. 2013 (SH Act)" across the country. The SHe-Box portal is live now (copy of letter of MoWCD is enclosed at Annexure-A).

The SHe- Box portal has been designed for effective implementation of the provisions of the SH Act, 2013. The Hon'ble Supreme Court has also passed directions for strict compliance of the provisions of the Act in the matter of Aureliano Fernandes Vs State of Goa & Ors. The structure of the portal has been so designed that in the absence of uploading of information of Internal Committee (IC) by the office/ authority concerned, the complainant won't be able to lodge her complaint through the portal.

It is requested that a <u>nodal officer</u> may be appointed to oversee and monitor your organization's activities on the She-Box portal. Additionally, the necessary information must be submitted via the following Google form (<a href="https://forms.gle/x GY k Yk coqWuQzJAJ9">https://forms.gle/x GY k Yk coqWuQzJAJ9</a>) to facilitate your organization's registration on the She-Box portal by this office. Upon completion of the registration process, your organization is required to follow the steps outlined in the Annexure-B.

- 2. Open your web browser- https://www.shebox.wcd.gov.in/.
