- Initially the empanelment will be for one year from the date of notification and can be extended further for a maximum of three years with the consent of both parties. The University may curtail or terminate the contract owing to deficiency of services, breach of contract, reduction of cessation of the requirement or for any appropriate reason.
- The Government/Statutory fee as per the applicable Schedule 1 of the Patents Act 1970 will be charged extra. The GST is inclusive in the rates.

The University will provide financial assistance to its students and faculty as per Clause 2.a (Scope of support) of Patent & Licensing Policy of the University and all applications shall be processed as per Clause 4 of this policy.
