60th AMENDMENT/ADDITION IN THE STATUTES OF DR. YASHWANT SINGH PARMAR UNIVERSITY OF HORTICULTURE AND FORESTRY STATUTES, 1987.

**Short Title:** This amendment/addition may be called Dr. Yashwant Singh Parmar University of Horticulture and Forestry, Nauni (Solan) Statutes, 1987 (60th

Amendment, 2023)

Incorporation of additional Section 7.29 in Chapter-VII of the Statutes of Dr. Yashwant Singh Parmar University of Horticulture and Forestry Statutes, 1987

The following addition shall be made under Chapter-VII of Statute of Dr. Yashwant Singh Parmar University of Horticulture and Forestry Statutes, 1987:

## **Incorporation of additional Section in Chapter-VII of Statutes**

7.29 Every teaching as well as non-teaching employee either appointed on contractual or on regular basis, on or after 01.04.2022, shall have to serve for a minimum period of three years [including contractual period as well as maternity/paternity/medical leave(s)] in any of the constituent College/Research Station/Krishi Vigyan Kendra of the University during anytime within 14 years of their service i.e. before the elevation or promotion in their respective grade whichever is due in their service career after 14 years from their initial appointment. However, this condition will not apply to the employees who do not get any posting outside the University within 14 years of their services from the date of their initial appointment (on or after 01.04.2022) due to administrative reasons.
