This is for the information of all the candidates that keeping in view the ensuing State Legislative Assembly bye-elections in the three constituencies of the Himachal Pradesh scheduled to be held on 10th July, 2024, the University has decided to postpone the 2nd round of counselling for Undergraduate Degree Programme under Normal and Self-Finance Seats previously scheduled to be held on 10th and 11th July 2024 respectively, as under:

Simultaneously, considering the problems being faced by the candidates coming from the North-Eastern States, J&K and Ladakh UT to the main campus at Nauni, Solan to attend the counselling, who had applied for reserved self-financing quota seats, the University has decided to conduct the counselling for all the candidates of North-Eastern States, J&K and Ladakh UT on 12.07.2024.

However, the cut-off criteria for rest of the candidate for appearing in the second round of counselling for the normal as well as the self-financing seats, along with the vacancy position, will be notified on 9th July 2024.
