NOTICE

The office of the undersigned has received several applications for Change of Major from students admitted to the Master's Degree Programmes for the Academic Session 2025-26.

However, fresh applications for Change of Major are hereby invited from all eligible and desirous students admitted to the Master's Degree Programmes through **PGET-2025** for the Academic Session **2025-26**. Requests for Change of Major shall be submitted strictly in the prescribed proforma appended as **Annexure-I**.

All desirous students, after filling in all required details and getting the same verified and signed by the Major Advisor, are required to submit the duly filled proforma to the concerned Head of the Department on or before **04th February, 2026**. Students who had applied earlier are also required to submit fresh applications. Applications not submitted in the prescribed format or received after the above-mentioned date shall not be entertained and shall be rejected outright.

The Major Advisors and the Heads of Departments shall verify the particulars, including the details of the courses furnished in the proforma attached as Annexure-I, and forward the same to the respective Deans. The office of the Deans shall thereafter cross-verify the particulars, including 'good' academic standing, and forward the cases to this office on or before **06th February, 2026**.

A tentative discipline-wise and college-wise vacancy position received from the concerned offices of the Deans is enclosed as **Annexure-II**. However, the final vacancy position may vary, as internal adjustments may be made prior to allotment, including the adjustment of students with higher merit from Self-Financing seats to Normal seats. Students must note that the Change of Major shall be carried out strictly on the basis of merit in PGET-2025 and in accordance with the guidelines prescribed in the Prospectus for the Master's Degree Programmes for the Academic Session 2025-26 and relevant Academic Regulations.

It is mandatory for all applicants seeking Change of Major to appear in person before the Change of Major Committee on **10th February, 2026 at 11:00 AM** in the **Alumni Centre, Dr. Y.S. Parmar University of Horticulture and Forestry, Nauni**. The

applicants shall mark their attendance and present themselves before the Chairman of the Committee, who shall oversee the Change of Major process.

Once the Change of Major is finalized, it shall be treated as final and binding, and no request for reversion or further change shall be entertained. Any seat vacated during the process shall be immediately reallocated to other eligible candidates. Students are, therefore, advised to exercise due caution while submitting their applications.

Students are also advised to regularly visit the University website for further updates, if any.
