OFFICE ORDER

In compliance of the letter No. Per (AP-B B (15)-5/2022 dated 18/11/2022 from the Chief Secretary to the Government of Himachal Pradesh, the Vice Chancellor has been pleased to reintroduce the process of marking attendance on AADHAR based Biometric Attendance System (BAS) for all the teaching and non-teaching staff from **January**, 2023 onwards.

Further, the Hon'ble High Court of Himachal Pradesh has passed the order in CMPs No. 2126 and 2127 of 2020 in CWP No. 1160/2019 titled as Vipin Kumar Guleria versus State of Himachal Pradesh and others on 26.02.2020 and operative part of the said orders is as under:-

"Accordingly, the present application is disposed of reiterating that the teaching and non-teaching staff of the applicant-University i.e. Dr. Yashwant Singh Parmar University of Horticulture and Forestry, Nauni, Solan, shall mark their attendance through the Biometric System and failure to do so shall entail consequences as have already been spelt out in the judgement dated 08.01.2020".

However, the Incharge, Computer and Instrumentation Centre-cum-Nodal Officer will keep liaison with National Informatics Centre (NIC) and may take necessary action to make the Biometric Attendance System (BAS) functional by **26.12.2022** positively with the present infrastructure so as to ensure the compliance of the orders of the Hon'ble High Court in letter and spirit. In case any additional equipment/BAS machines are required, he may submit the proposal and procure the same after completing the required codal formalities.
