Educational Qualification	Same as for other candidates					
Other requirements	Such Candidate shall have to secure minimum of 45 marks in the entrance test as is applicable to other candidates.					

<u>CRITERIA</u>: The benefit of this reservation shall be availed of only by the legal heirs/sons/daughters of those families, whose land has been acquired for the establishment of this University at the main campus in Nauni. The benefit of this reservation shall be extended only once to one family.
