This is for the information of the candidates seeking admission to **Master's Programme** of this University for the Academic Session 2023-24 that the University has received a large number of requests from candidates, who have passed their qualifying degrees from outside this University to **postpone** the 1<sup>st</sup> counselling scheduled to be held on **07.07.2023** as their degrees/results are yet to be issued/ declared.

In view of this, it has been decided to re-schedule the counsellings for admission to Master's Programme in offline mode as under: -

It has also been decided that the candidates having passed B.Sc. (Hons) Horticulture 4-year programme, B.Sc. (Hons) Forestry 4-year programme, B.Sc./ B.Tech. Biotechnology 4-year programme/ B.Tech. Food Technology 4-year programme (being 1<sup>st</sup> preferred qualification in their respective disciplines) (as per Prospectus, Chapter-IV) and have **secured qualifying marks i.e. 45 marks and above** in the entrance test will be eligible to attend the 1<sup>st</sup> counselling re-scheduled to be held on 17.07.2023. Rest of the candidates, who have **secured 50 marks and above** (having passed B.Sc. (Hons) Agriculture, B.Sc. Medical, B.Sc. Non-Medical, B.Sc. Environmental Science etc. will be eligible to attend the 1<sup>st</sup> counselling.

Accordingly, the desirous candidates, may now report for **1<sup>st</sup> counselling** at **Dr. L.S. Negi Auditorium** in the main campus at Nauni (Solan) at **10.00 AM** but not later than **11.30 AM** for marking their attendance. It is mandatory for the candidates to present themselves before the chairman of the Counselling Committee. The candidates, who fails to present themselves before the counselling committee even after marking their attendance shall not be considered for admission.
