

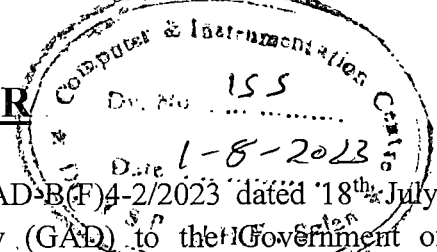





Order/Appeal

Whereas, you are aware, our nation as well as Himachal Pradesh recently went through a devastating natural disaster due to continuous heavy rains which has left countless individuals and families in dire need of assistance. The aftermath of this calamity has caused extensive damage destruction to life and property of people of state, thus, affecting the lives and livelihood of many innocent people. It is felt that concerted and co-ordinated efforts on part of the State Government, civil society and all citizens are required to bolster the infrastructure in the State in this hour of need.

In view of the various requests received from the various associations of govt. employees and pensioners, the Government has set up the " आपदा राहत कोष-2023 " which aims to provide immediate relief and long term rehabilitation to those affected.

Now therefore, it is hereby directed with the approval of the competent authority, that all the Drawing and Disbursing Officers in various Departments/ Public Sector Undertakings/ Autonomous bodies under the Government of Himachal Pradesh shall deduct one day's gross salary/ emoluments/ pension of each employee working on regular/contract basis and pensioners. 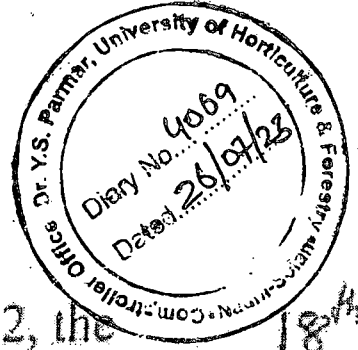
