

FOR THE POSITION OF THE VICE-CHANCELLOR OF KSKV KACHCHH UNIVERSITY, BHUJ-370001

The Chancellor of the University, the Honourable Governor of Gujarat, has constituted a Search Committee for recommending a panel of names for the post of Vice-Chancellor of the KSKV Kachchh University. The KSKV Kachchh University is state University established under the KSKV Kachchh University Act, 2003. The Committee invites applications/nominations for the appointment of Vice Chancellor along with the detailed bio-data.

A person possessing the highest level of competence, integrity, morals and institutional commitment is to be appointed as Vice-Chancellor. The person to be appointed as a Vice Chancellor should be a distinguished academician, with a minimum of 10 years of experience as Professor in a University system or Ten Years of experience in a reputed research and/or academic administrative organization with proof of having demonstrated academic leadership can apply or be nominated.

Present and former Vice-Chancellor, Director, Head of Institution of Higher learning/Research Institution and an eminent scholarly person are invited to nominate. The Search Committee reserves the right to consider person of eminence outside the list of such applications/nominations. In accordance with the procedure evolved by The Committee, nominees would be short listed based on agreed parameter and as per the provision of KSKV Kachchh University Act and UGC Notifications from the time to time in this regards.

The person should be a well-rounded personality and should have contributed significantly to the development of higher education. He/She apart from being a good researcher should also possess adequate administrative experience. He/She should not exceed 62 years of age as on the last date of application.
