- that your appointment to the said post is purely temporary and can be terminated at any time without assigning any reason.

- that you shall not be paid any TA/DA for joining the post. IV.
- that since the post is purely temporary, you shall have no claim for regularization against the post.
- that no other service benefits are attached with the post and you will not be entitled for the benefits being enjoyed by the regular employees of this University in accordance with the rules.
- that your headquarters is liable to be changed anywhere in Himachal Pradesh. VII.
- that you shall be required to submit monthly progress report of the work done by you under the research project to the Principal Investigator/Head of the department and also maintain proper records of Research, Teaching and other experimental data and relevant records thereof, information and also account for the income, expenditure and goods vouchers etc. The necessary vouchers/receipts will be open for inspection by the University authorities.
- that in case of unsatisfactory performance, the emoluments can be withdrawn. IX.
- that University will not be obliged to provide any transport facility from your residence to the place of work.
- that taking part in strike or creating any type of indiscipline will result to the XI. termination from the post without serving any notice.

- XII. that you will not be entitled for any kind of leave except 15 days' casual leave, 2 days Restricted Leave in a calendar year and maternity leave as per rules.
- XIII. That you have to serve one-month notice prior to resignation or have to deposit one-month salary on immediate resignation.
- XIV. That you shall have to execute service contract agreement in triplicate on judicial stamp paper worth Rs. 15/- at your own cost duly attested and registered with the Executive Magistrate or Notary Public and ensure that the terms and conditions should be mentioned in accordance with appointment letter.

In case the above terms and conditions are acceptable to you, you may report for the duty to the Professor & Head, Department of Forest Products, UH&F, Nauni (Solan) with in a period of **35 days** from the issuance of this letter, failing which the appointment shall be treated as cancelled.
