It is for the information of all the candidates seeking admission to the Doctoral Programmes of this University for the Academic Session 2023-24, that there are few seats still lying vacant (Normal as well as Self-financing Seats) after two rounds of the Counselling. Therefore, it has been decided to hold a special round of counselling on **12.02.2024** in the **Office Chamber of the Dean, College of Horticulture, Nauni (Solun)**. The eligibility Criteria for appearing in the Counselling is as under:

SN	Category	Criteria for appearing in the Counselling
1	Normal Seat (SC/ST Only)	Candidates having secured 45 and above marks are eligible for the normal seats reserved for the SC/ST Categories
2	Normal (UR-General)	Candidates having secured 50 and above marks are eligible for the normal seats
3	Self-financing seat	All the candidates having Secured 45 marks and above are eligible for consideration as per merit.

It is also informed that the Candidates with dissertation in Master's Degree Programme will also be considered for admission to the Doctoral Programmes for the Academic Session 2023-24. The rest of the criteria for appearing in the counselling shall remain same as outlined in the prospectus. The desirous candidates may appear in the Counselling at 10:00 AM but not later than 11:30 AM for availing a chance of allotment of seat. **The discipline-wise vacancy will be uploaded on the university website later on.** Furthermore all candidates are advised to bring original certificates along with a set of Xerox copies while reporting for the Counselling.
