Group-C	<b>LEVEL 3 to LEVEL 10</b> (Pre-revised ₹ 5910-20200 + ₹ 1900 GP to ₹ 10300-34800 + ₹ 3600 GP)
Group-D	<b>LEVEL 1 &amp; 2</b> (Pre-revised ₹ 4900-10680 + ₹ 1650 GP & ₹ 1800 GP)
