





IT HAS ALSO BEEN DECIDED THAT THE STATE FUNERAL WILL BE ACCORDED TO LATE DR. MANMOHAN SINGH (.) THE STATE GOVERNMENT HAS FURTHER DECIDED THAT ALL OFFICES UNDER THE CONTROL OF HIMACHAL PRADESH GOVERNMENT INCLUDING BOARDS AND CORPORATIONS AND ALL EDUCATIONAL INSTITUTIONS WILL REMAIN CLOSED FOR TWO DAYS ON THE 27TH AND 28TH DECEMBER, 2024 AS A MARK OF RESPECT TO THE DEPARTED LEADER (.) THESE TWO DAYS WILL BE PAID HOLIDAYS FOR ALL DAILY WAGES EMPLOYEES OF STATE GOVERNMENT ESTABLISHMENTS (.) PLEASE TAKE ACTION ACCORDINGLY (.)
