## NOTIFICATION

The Academic Council, vide Item No 18. and Sub-item No. (v) of its proceedings of its 117<sup>th</sup> meeting held on 30.07.2024 has approved that a change of major for Master's degree students shall be permitted at the university level, after the completion of one semester, provided the student fulfils the eligibility requirements for admission to the discipline to which the change is sought.

This office has received several applications for a change of major. **However, fresh applications are now invited from all eligible and desirous Master's degree students admitted through PGET-2024 for the Academic Session 2024-25.** Applications must be submitted in the prescribed format, attached as **Annexure-I**, in person or thorough email to the concerned Head of the Department on or before **10<sup>th</sup> January 2025**. The students who have applied earlier must also submit fresh applications.

The Heads of Departments are requested to forward the applications received in their departments and forward them to the respective Deans. The Deans, after consolidating and reviewing all applications from the concerned Heads of Departments, may submit the compiled and duly recommended applications to this office by **13<sup>th</sup> January 2025**. Any applications received after this date will not be considered. A tentative discipline wise and college wise vacancy list is attached as **Annexure-II**, however, the final vacancies may vary as internal adjustments will also be made before seat allotment, ensuring students with higher merit marks are shifted from self-financing seats to normal seats. The change of major will be determined strictly based on the merit of PGET-2024 and the guidelines provided in the prospectus for the Master's degree programme for the Academic Session 2024-25. **Additionally, only applications requesting a change of major will be considered, requests for a change of college within the same discipline will not be entertained.**

It is mandatory for all students seeking a change of major to appear before the committee on **17<sup>th</sup> January 2025** at the main campus, Nauni. The students must mark their attendance and present themselves before the Chairman of the Committee, who will oversee the change of major process only.

Once the change of major is finalized, it will be considered final and no requests for reversion or further changes will be entertained. The seat vacated by a student during the process will be immediately reallocated to other eligible candidates. The students are therefore advised to carefully consider their preferences before submitting their applications, as the choice made will be final and binding.
