Applications on the prescribed form which can be downloaded at University website http://www.yspuniversity.ac.in are invited from the desirous candidates, for filling up of following Class-IV posts under different Krishi Vigyan Kendras of the University. The application will however be considered valid only, if it is accompanied with the prescribed fee mentioned at Sr. No.1 under "Important Instructions/Other Conditions" below, in the shape of Bank Draft drawn on State Bank of India/UCO Bank Nauni (Solan)-173230 (HP) payable to the Comptroller, Dr. Y.S. - 2. The candidate shall be eligible for appointment, if he/she has passed Middle or Matriculation from any School/Institution situated within Himachal Pradesh. <u>However, this condition of region shall not apply to Bonafide Himachalis</u>.
- 3. A candidate applying for more than one post should send/submit separate application form for each post alongwith prescribed application fee.
- 4. The Category once claimed by the candidate(s) in his/her application form will not be allowed to be changed at any stage.
- 5. Application fee once paid will not be refunded.
- 6. The engagement to the above posts shall be governed by the provisions of guidelines issued vide Department of Personnel's letter No.PER(AP)-C-B(15)-3/2024-Loose dated 14.05.2025 read with letter of even number dated 15.05.2025, further notified by the University vide Notification No.UHF.Regr.Rectt.2-106/2025/-5855-76 dated 28.05.2025. The engaged trainee shall be paid consolidated fixed amount @ ₹ 10,800/- per month which shall be 60% of Cell-1 of Level-1 of HPCS (RP) Rules, 2022.
- 7. The applicant must be a Citizen of India.
- 8. Candidate should be minimum of 18 years and not more than 45 years of age. The upper age limit is relaxable by five years for candidates belonging to the Scheduled Caste/Scheduled Tribe/Other Backward Class/Persons with Disabilities, of Himachal Pradesh only, as per provisions in Rules/Instructions of the H.P. Government. The minimum and maximum age limit shall be reckoned as on 01.01.2025. It is further clarified that the upper age limit fixed in the advertisement shall not be applicable in case of candidates already in service in Government/Semi-Government Institutions, as per State Government rules.
- 9. The date of determining eligibility of all candidates in respect of essential qualification(s) and experience, if any, shall be the prescribed last date for receipt of applications i.e. <u>05.07.2025</u> for candidates from Non-Tribal Areas and <u>15.07.2025</u> for candidates from tribal areas.

10. In view of Department of Personnel's, Government of HP, Notification No.Per(AP.B)B(15)-5/2014 dated 17.04.2017, further adopted by the University, vide Notification No.UHF.Regr.Rectt.2-39/2017/-27703-27745 dated 26.12.2017, the preliminary selections to these posts shall be made on the basis of percentage of marks obtained in qualifying examination to be calculated out of 85. For example, a candidate getting 50% marks in Matric will be given 42.5 marks followed by evaluation, based on the following parameters. Besides, there will be physical test for the post of Beldar which will be of qualifying nature, only:

11. The initial merit list will be drawn on the basis of marks obtained by a candidate in the qualifying examination i.e. (i) Matric for the post of Peon and (ii) Middle (8th) for the post of Beldar, <u>out of 85 marks</u>. On the basis of same, the candidates shall be shortlisted for physical test or evaluation/documentation of <u>further 15 marks</u> (Final Selection:- 85+ 15= 100 marks), as the case may be, in the ratio of 20

times of total number of posts/vacancies. As such, the candidates are strictly advised to submit the attested copy of their Detailed Mark Sheets of (i) Matric Certificate for the post of Peon, and (ii) Middle (8th) Certificate for the post of Beldar, failing which their application will not be considered and rejected straightway.

- 12. The reserved category candidates belonging to other States will be treated as <u>GENERAL CATEGORY</u> <u>CANDIDATES</u> and the benefit of reservation and fee concession will not be admissible to such candidates.
- 13. The candidates belonging to Other Backward Class of HP category must possess OBC certificate(s) on the prescribed format, which should not be more than one year old at the time of last date fixed for submission of application forms. The candidate shall have to produce the original valid certificate as well as the old certificate in support of his/her claim, at the time of documentation.
- 14. The certificate of Scheduled Caste, Scheduled Tribe, Other Backward Class should be on parental basis, failing which candidature of such candidates will be rejected.
- 15. Applicants already in service should send their application forms through proper channel with advance copy to this University.
- 16. Number of post(s) is/are tentative and may increase or decrease from time to time for different categories of post.
- 17. Canvassing in direct or indirect manner will be a disqualification.
- 18. Any further information about qualifications or job requirements can be had from the Recruitment Section, office of the Registrar.
- 19. Incomplete applications or those received after the last date will not be entertained and rejected straightway.
- 20. The University reserves the right not to fill up the post, without assigning any reason.
