consequent upon the revision of pay scales in Himachai Pradesh with effect from 1st January, 2016, the Finance Department vide their 7000 No.FIN(PR)-B(1)-1/2022 dated 7th September, 2022 had laid down the norms for re-classification of posts. Accordingly, the Department of Personnel vide letter of even number dated 22.11.2022 had issued instructions to all the Administrative Department for carrying out the necessary amendments in relevant Recruitment and Promotion Rules.

2. Now, in suppression of OM dated 07.09.2022, as referred to above, the Finance Department vide OM No. Fin(PR)B(1)-1/2022, dated 10th July, 2025 has laid down the norms for re-classification of posts, as under:-

"Group-A LEVEL 16 TO LEVEL 31

- 3. Consequently, the instructions issued vide this Department's letter of even number dated 22.11.2022 are superseded and amendments, if any, carried out in the Recruitment and Promotion Rules in pursuance to these instructions may be modified as per revised classification detailed at Para-2 above.
 - As a result thereof, all the Recruitment and Promotion Rules are required to be amended in so far as the classification of posts is concerned. Since the Classification of posts is directly linked with the revision of pay scales for which the Council of Ministers has already authorized the Finance Department to issue the orders linked with the revision of pay scales, the Finance Department has already fixed the revised norms for reclassification of the posts under the powers delegated by the Cabinet. As such, there is no need to follow the prescribed procedure i.e. consultation of all advisory departments/HP Public Service Commission for making this amendment in the concerned Recruitment and Promotion Rules.
 - 5. Therefore, the Administrative Departments are requested to carry out this amendment in all the relevant Recruitment and Promotion Rules at their own level, after completion of all codal formalities i.e. obtaining prior approval of the Competent Authority.
 - 6. These instructions may be brought to the notice of all concerned for strict compliance.
