This has a reference to this office Auction Notice No. UHF/RHRSS/KVK/17-1-331-336 dt 28.08.2025 vide which date for receiving sealed tenders for auction of apple fruit (Natural Farming) at KVK Tabo was mentioned as 12.09.2025. Now, keeping in view the unprecedented rains and consequent damage to roads in Kinnaur and Lahaul & Spiti, the sealed bids for the auction of Apple Fruit crop of Natural Farming Block (except trees marked "Out of Auction") of RHRSS & KVK Lahaul & Spiti-II (Tabo) for the year 2025 are invited through post or in person on or before 30/09/2025 at 10.30 AM at RHRSS & KVK Lahaul & Spiti-II (Tabo). **The bidder has to drop his/her bid offer in prescribed format (Copy enclosed) in the tender drop box in the office of undersigned.** The bidder must write his/her name and address on the sealed bid and the word "**Quotation for Apple Crop (Natural Farming)**" on the top of sealed envelope. The bid shall be opened by the committee on same day i.e. on 30/09/2025 at 3.00 PM at RHRSS & KVK Lahaul & Spiti-II (Tabo) in the presence of the bidders.

The interested bidders may inspect the apple crop by visiting the apple orchard on any working day with the prior permission of the undersigned. The interested bidders participating for the auction should deposit an earnest money amounting to Rs. 20,000/- (Rupees Twenty thousand only) in cash/DD payable to "The Senior Scientist and Head, Krishi Vigyan Kendra, Tabo" at SBI, Tabo for apple fruit crop, which will be refundable to the unsuccessful bidders. The successful bidder will have to deposit the full amount on the same day through DD payable to "The Senior Scientist and Head, Krishi Vigyan Kendra, Tabo" at SBI Tabo or through online mode in the A/c No. 38325986898, IFSC No. SBIN0006987 of Sr Scientist and Head, KVK Tabo. The reserve price has been kept at Rs. 3.0 Lakh only. The committee will have the right to reject any/all bids without assigning any reason or may cancel the auction process if the required bidders are not available during auction or quoting less bid than the reserve price or on any technical reasons/grounds noticed by the committee.
