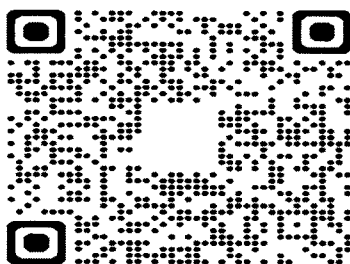

All participants who wish to attend the Convocation must report for rehearsal on 09th December, 2025 (Tuesday) at 12:30 PM in the University Auditorium, which will continue till 5:00 PM. Only those Graduates and Postgraduates who attend the rehearsal will be permitted to participate in the Convocation Ceremony, as the allotment of seats for the Convocation will be finalized during the rehearsal only.

All degree recipients who have attended the rehearsal must report to the University Auditorium on 10th December, 2025, by 9:00 A.M. sharp (one hour before the commencement of the Convocation). The auditorium doors will be closed strictly at 9:00 A.M., and no exceptions will be entertained, even for those who attended the rehearsal.
