Subject :- Regarding grant of any allowances or other financial benefits in the
Universities.
Sir,

It has come to the notice of the Government that certain Universities are extending allowances and other financial benefits to their employees by adopting instructions issued either by the State Government or the Government of India without obtaining prior approval of Finance Department.

It is reiterated that Universities are run on the Grant in Aid (GIA) provided by the State Government and granting such allowances or financial benefits without the approval of the Finance Department puts an additional burden on the limited GIA resources, thereby adversely affecting the capacity of the Universities to utilize funds for essential academic and developmental purposes. In many such cases, the likelihood of litigation also increases, which consequently attracts responsibility on behalf of the Government.

You are, therefore, requested not to grant any allowance or other financial benefit to University employees even by adopting instructions issued by the State Government or the Government of India unless such proposals have been specifically approved by the Finance Department. All such proposals must invariably be referred to this Department for detailed examination and formal approval prior to their implementation.

The above instructions may be strictly complied with by all Universities. Any deviation will be viewed seriously and may attract administrative consequences.


