For submission of bid, the bidder is required to have Digital signature Certificate (DSC) from one of the authorized Certifying Authorities (CA) "Aspiring bidders who have not obtained the user ID and password for participating in e-tendering in HPPWD may obtain the same from the website : <http://hptender.gov.in>. Digital Signature is mandatory to participate in the e-tendering bidders already possessing the digital signature issued by authorized CAs can use the same in this tender.

3. **Submission of Original Documents:** The bidders are required to submit (a) Original demand draft towards the cost of bid document and (b) Original bid security / earnest money deposit (EMD) in shape of FDR duly pledged to EE UHF Nauni and other technical documents in O/o the Executive Engineer, UHF, Nauni, Solan (HP) as the specified in key dates on tender opening date, failing which the bids will be declared non responsive.
4. **Eligibility Criteria:**
- (i) For work at Sr.No.1 above, the bidder/ contractor has not have more than two contracts at a time each of more than Rs.1.00 (One Crore) or more in any HPPWD Circle/ Division/ or any Govt. organizations. (This eligibility condition shall be applicable for those works of amount awarded cost of which is greater than Rs.1.00 Crore as per Govt. Notification No.PBW(B)F(1) 1/2023 dated 04.10.2023). The contractor has to submit list of incomplete works in hand on the proforma mentioned at Sr.No.16 of General Rules and Directions.
 - (ii) For work* at Sr.No.2, the bidder/ contractor should have executed similar type of work in any HPPWD Circle/Division or any Govt. organizations.
5. **Bid Opening detail:** The bids shall be opened on **30-01-2026** in the office of Executive Engineer UHF Nauni, Solan (HP) by the authorized officer/officials. In their interest **the tenderer are advised to be present along with original documents at the time of opening of tender**. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
6. Other details can be seen in the bidding documents. The officer inviting tender shall not be held liable for any delay due to system failure beyond its control. Even though the system will attempt to notify the bidders of any bid updates, the employer shall not be liable for any information not received by the bidder.
