3. **Submission of Original Documents:** The bidders are required to submit (a) Original demand draft towards the cost of bid document and (b) Original bid security / earnest money deposit (EMD) in shape of FDR duly pledged to EE UHF Nauni and other technical documents in O/o the Executive Engineer, UHF, Nauni, Solan (HP) as the specified in key dates on tender opening date, failing which the bids will be declared non responsive.
4. **Bid Opening detail:** The bids shall be opened on 04-02-2026 in the office of Executive Engineer UHF Nauni, Solan (HP) by the authorized officer/officials. In their interest the tenderer are advised to be present along with original documents at the time of opening of tender. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
