NOTICE

It is for the information of all concerned that, after considering the numerous requests received from candidates and on the recommendations of all the Deans of the Constituent Colleges, the Competent Authority has approved an **increase in the number of seats in various disciplines for the 2nd round of counselling for the Doctoral Degree Programme of the Academic Session 2025-26.**

The updated **category-wise and discipline-wise vacancy position** for the **Second Round of Counselling**, after the approved increase of seats for different Colleges, is enclosed as **Annexure-II**.

I. Eligibility Criteria

The eligibility criteria for participation in the Second Round of Counselling shall remain unchanged. Accordingly, all candidates who have secured **50 marks or above (45 marks in case of SC/ST/PwD categories)** for **Normal seats** and **35 marks or above** for **Self-Financing seats** in the Entrance Test are eligible to participate.

II. Schedule of Counselling

Second Round of Offline Counselling for Doctoral Degree Programme (Normal & Self-Financing Seats), Academic Session 2025-26

- **Date:** 02nd February, 2026
- **Reporting Time:** 10:00 AM to 11:00 AM (for marking attendance)
- **Venue:** Dr. L. S. Negi Auditorium, Main Campus, Nauni (Solan)

III. Documents Required at the Time of Counselling

Candidates are required to bring **original documents along with one set of self-attested copies** of the following:

1. Matriculation (10th) Certificate (for date of birth) - *Compulsory*
2. Graduation Degree Certificate - *Compulsory*
3. Master's Degree Certificate / Provisional Degree Certificate - *Compulsory*
4. Transcript of Academic Record of Master's Programme - *Compulsory*
5. Character Certificate from the Institution last attended - *Compulsory*
6. Himachal Pradesh Domicile Certificate (mandatory for HP candidates applying for Normal seats)
7. Copy of cover page of Master's Degree Thesis and Abstract - *Compulsory*
8. Certificates, wherever applicable:
 - SC / ST / EWS

- Person with Disability (PWD)
- Any other relevant certificate

Candidates must also bring their **Master's Degree Thesis/Dissertation** for verification, if required by the Counselling Committee.

IV. Counselling Fee

Candidates attending the counselling process for the first time are required to deposit a **non-refundable counselling fee of ₹1,000/-** through the QR code or payment link provided in **Annexure-I** on the eShiksha Portal and download the receipt generated therefrom.

Only the **receipt generated from the eShiksha Portal** shall be accepted as valid proof of payment. No other proof of payment (such as UPI screenshots, bank messages, or card transaction details) shall be accepted. The **hard copy of the eShiksha receipt** must be produced at the time of counselling.

Mere payment of the counselling fee does not guarantee allotment of a seat. Seats shall be allotted strictly on the basis of merit, availability of seats, eligibility conditions, and other provisions laid down in the Prospectus for admission to the Doctoral Degree Programmes for the Academic Session 2025-26

Candidates who have already paid the requisite fee during the First Round of Counselling are required to bring valid proof of payment, i.e. the hard copy of the eShiksha receipt, at the time of counselling.

V. Sports and Co-Curricular Activities Seats

Seats under the Sports and Co-Curricular Activities category shall be considered strictly on the basis of the certificates submitted during the First Round of Counselling and the merit drawn thereon.

All interested and eligible candidates must be physically present for allotment of seats. Seats under the Sports and Co-Curricular Activities category shall be allotted first during the counselling. Therefore, candidates who have applied under the said category must report between 10:00 AM to 11:00 AM, as seats shall be allotted strictly to candidates who are present at the time of allotment and present themselves before the Chairman of the Counselling committee.

VI. Important Instructions

1. If a candidate has not opted for self financing seat at the time of filling the online application form such candidates may also apply consideration under Self financing Category by depositing an additional non-refundable fee of ₹ 5,000/- at the counselling venue at the time of counselling.
2. All interested and eligible candidates must be present for seat allotment. Seats shall be allotted only to candidates present at the time of allotment.
3. Candidates arriving after the prescribed reporting time shall forfeit their right to be considered for allotment against the seats already allotted and shall be considered only against vacancies available at that time.

4. It is mandatory for candidates to mark their attendance and appear before the Chairman of the Counselling Committee.
5. Candidates who mark attendance but fail to appear before the Chairman of the Counselling Committee shall not be considered for admission.
6. In the event that no eligible candidate is available under a particular category, conversion of seats shall be carried out strictly in accordance with the norms prescribed in the Prospectus. Final calls for allotment shall be made from the stage, and if no candidate presents himself/herself at that time, the seat(s) shall be opened for conversion as per the prescribed norms.


