
Terms & Conditions:-

2. The minimum age of the candidate will be 21 years and maximum 45 years with relaxation as per rule.
3. The upper age limit is relaxable for reserved category candidates as per Govt. of India norms.
4. The recruitment is purely on temporary basis and is initially for a period upto 31.03.2027 or may be extended subject to the availability of fund or termination of the project. However, depending on the unsatisfactory progress, the appointment can be terminated at any time by issuing one month notice.


