ADDENDUM TO ADMISSION NOTICE

2. Minimum Eligibility and Admission Procedure

(i) Master of Business Administration (MBA)

a) Minimum Qualification: Graduate in any discipline with a minimum of 50% marks (45% for SC/ST candidates) under the Annual System; OR its equivalent under the Course Credit System from a recognized University.

b) Entrance Test: Admission shall be through the Postgraduate Entrance Test (PGET) to be conducted on **12.07.2026 (Sunday)** at the Main Campus, Nauni (Solan). The test shall comprise 100 multiple-choice questions, each carrying one mark, with a duration of 2 hours. There shall be no negative marking. The section-wise pattern is as under, and the detailed syllabus is attached as **Annexure-I:**

c) Semester Fee: Same as applicable for self-financing seats for Master's Degree Programmes. For details, please refer to Chapter X of the prospectus for admission to the Undergraduate and Master's Degree Programmes for the Academic Session 2026-27.

(ii) B.Sc. (Hons.) Agribusiness Management

a) Minimum Qualification: Candidates who have passed 10+2 or equivalent examination in **English** along with any **three** subjects from the following Physics, Chemistry, Biology/Mathematics, Agri. Physics, Agri. Chemistry, Agri. Biology, and Agriculture, from a recognized Board with a minimum of **50% aggregate marks** (45% for SC/ST / PwD / Orphaned Children / In-service nominees of the Himachal Pradesh Government).

b) Admission Procedure: There is **no separate entrance test** for this programme. Admission shall be **merit-based**, determined on the marks obtained at the 10+2 level in English along with any other three of the above-mentioned subjects. In case two or more candidates obtain equal marks, the candidate **elder in age** shall be given preference.

c) Semester Fee: Same as applicable for self-financing seats for Undergraduate Degree Programmes. For details, please refer to Chapter X of the prospectus for admission to the Undergraduate and Master's Degree Programmes for the Academic Session 2026-27.

(iii) M.Sc. Agricultural Meteorology

a) Minimum Qualification: B.Sc. (Hons.) Forestry / B.Sc. Forestry / B.Sc. (Hons.) Horticulture / B.Sc. Horticulture / B.Sc. (Hons.) Agriculture / B.Sc. Agriculture 4-year programme from a recognized University with an OGPA of 6.00/10.00 under the Course Credit System or a minimum of **60% marks** under the Annual System (relaxable by 5% for SC/ST / PwD candidates and In-service nominees).

b) Entrance Test: Admission shall be through the Postgraduate Entrance Test (PGET) to be conducted on 12.07.2026 (Sunday) at the Main Campus, Nauni (Solan). The syllabus and pattern of the entrance test shall be the same as applicable to the other Master's Programmes of the University, based on the qualifying degree. The details and section-wise breakup of the entrance test are as given on page 68 of the Prospectus. The syllabus for the same is given in Annexure-II of the Prospectus on page 105.

c) Semester Fee: Same as applicable for self-financing seats for Master's Degree Programmes. For details, please refer to Chapter X of the prospectus for admission to the Undergraduate and Master's Degree Programmes for the Academic Session 2026-27.

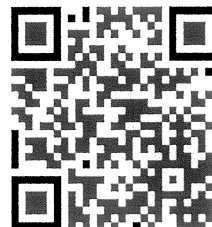
